She complains about the roles she has played but has never explored theater which might expand how she is cast. Apparently she has felt they were not justifications enough for her to consider.

It is hard comparing herself and her career to J's. High bar. Possibly unrealistic very hard for her to talk about.

Encouraged her to try drawing or painting when she is blue.

Sept 5 2014

Amber is anxious this AM. Was to travel to NYC for a job. Will be away 3 days. Being alone is always hard for a man for these few days. Not proud of the job she is to do but has agreed to do it for the money.

Money was central to our discussion today. She has been supporting her M + F for a number of years. She doesn't take money from J even though he has offered it to her. Very independent in this way as she was in her last rel. in the woman partner whom she supported.

Mother wants to retire and Amber has offered to support them entirely. I suggested she should really think all of that financial commitment through more clearly. Obvious people see her as having financial means because of her rel to J. Mother is only 58 y/o. Big decision. This is clearly a source of her anxiety. Also discussed Amber's proposed wedding. Pre-nup?? Nothing planned or in place. She is ambivalent about it.

We shall see if this leaves her less groggy in the morning, but still able to get a good sleep. All the other meds remain the same.

Amber is still anxious about going to Savannah for the movie. The plan is to fill in all the details she can before going. This is an imperfect plan for some of the logistics are not in her control, which is upsetting. That level of upset she will learn to deal with.

We discussed her frustration with her career. Also discussed some of the difficulties with bringing along an assistant to the shoot in October. My impression is that her relationship with J is much smoother. He continues to be supportive to her doing the movie. We discussed trying to lay in plans for visits while she is on location.

Amber reports using some of the tools I've given her actively and with good results. She seems pleased with herself, more confident.

She will be back in Los Angeles next Tuesday for a few days so will get some face time.

I love him more than anything but he is really difficult...

My heart and body are simply exhausted from this battle.

I really hope you can help me figure out how I can COPE with him. Despite his state.

Amber, I am very upset. I promised to communicate with you after Johnny's visit with the specialist this morning. I organized an appointment with the hand specialist with all the manipulation of their office scheduling to accommodate us, including security and my scheduling changes, only to learn upon arrival at Sweetzer this morning that io went to the house last night and engaged with him until 5am. Because of this he was so compromised from not sleeping that we couldn't get him to the appointment this morning (this is after putting him in the car, taking him to the doctor's office, but then turning around since he was not capable of interacting normally). Because of this I had to reschedule his appointment for tomorrow and push his surgery back which involves changing my appointments, personal and professional, to accommodate his need to get his hand repaired. Since Debbie and Erin are now away the nursing care (a nurse that works regularly with us) must also change her plans to accommodate the situation. I am committed to caring for both of you but this was very inappropriate to have compromised all that has gone into making these arrangements - for his care and everyone else's time. If you truly love this man please respect the issues that will allow him to get the care he needs. Also, I am confused. If you are convinced that all problems between the two of you stem from his drug abuse why would you have participated with mushrooms on the island during the wedding and Ecstasy in Australia? I want to help you both so please help me.

David, You once told me that no one was to blame for Johnny's behavior or decisions, other than Johnny. And I have to say that if Johnny stayed up, or was too drunk/ messed up to engage in his appt. this morning then it's Johnny's fault only. io took it upon herself to go there- I did NOT ask her to go. She went in a moment of fear for me because she has never seen me so upset or lost.....as she explained to me this morning. I did not ask her to go and frankly I was too upset last night to try and stop her (our SOBER MUTUAL friend) from getting clarity on how to best understand the situation. I couldn't stop her and frankly I barely registered that she left to go over there (as I was being talked down from a panic attack on the floor of my bathroom).

I haven't seen Amber since March 16, shortly before the news broke, she texted me that she "finally filed for divorce."

From very early on Amber has known this to be an unsafe and unhealthy relationship. This final breach has been a long time coming.

During these months that Amber has been in therapy we have picked through the permanent and stationary unhealthy elements in her rel. i.e. JD - his controlling nature, jealousy and suspiciousness, addiction to drugs and alcohol, and violent and indulgent temper. Her finally acknowledging the toxicity is a healthy move on her part despite all the storm and drang that has accompanied the filing.

I'm not surprised Amber realizes how much she is in need of being - treatment. Her call to me only followed her meeting with Mr. Ripper. Ripper called me and indicated he would terminate his treatment if Amber didn't show up. She was in therapy (continuing to Arg. for his meds = being motivated) enough to get her here but it will not be sufficient over time.

Amber arrived Friday, accompanied by an entourage of paparazzi. Had to close the gate. Subsequent to our arrival, I have received calls from the media that I have not returned in intent to Amber in how it full crisis mode and has not yet had the outpatient appointment. She is to return what has happened. She is accompanied by a number of lawyers and is focused with making some decisions. Amber's (i.e., does she opt to file a domestic violence complaint against JD, she has been damaged & by the way spun by the media - JD victimized by JD) could also happen.

Need to help her process upcoming decisions that would be healthy for her. Despite all, there is still ambiguity in her feelings toward JD. Decided at length, I also discuss for her to let go & finally, Am encouraged her to do so.

Note me concerned about her commitment to treatment and follow through. Will not pursue this. She needs to decide how motivated she is to deal with therapy.

Amber, I am very upset. I promised to communicate with you after Johnny's visit with the specialist this morning. I organized an appointment with the hand specialist with all the manipulation of their office scheduling to accommodate us, including security and my scheduling changes, only to learn upon arrival at Sweetzer this morning that io went to the house last night and engaged with him until 5am. Because of this he was so compromised from not sleeping that we couldn't get him to the appointment this morning (this is after putting him in the car, taking him to the doctor's office, but then turning around since he was not capable of interacting normally). Because of this I had to reschedule his appointment for tomorrow and push his surgery back which involves changing my appointments, personal and professional, to accommodate his need to get his hand repaired. Since Debbie and Erin are now away the nursing care (a nurse that works regularly with us) must also change her plans to accommodate the situation. I am committed to caring for both of you but this was very inappropriate to have compromised all that has gone into making these arrangements - for his care and everyone else's time. If you truly love this man please respect the issues that will allow him to get the care he needs. Also, I am confused. If you are convinced that all problems between the two of you stem from his drug abuse why would you have participated with mushrooms on the island during the wedding and Ecstasy in Australia? I want to help you both so please help me.

David, You once told me that no one was to blame for johnnys behavior or decisions, other than Johnny. And I have to say that if Johnny stayed up, or was too drunk/ messed up to engage in his appt. this morning then it's johnnys fault only. io took it upon herself to go there- I did NOT ask her to go. She went in a moment of fear for me because she has never seen me so upset or lost.....as she explained to me this morning. I did not ask her to go and frankly I was too upset last night to try and stop her (our SOBER MUTUAL friend) from getting clarity on how to best understand the situation. I couldn't stop her and frankly I barely registered that she left to go over there (as I was being talked down from a panic attack on the floor of my bathroom).

She did not keep him up. Or make him drink.
Nor did I.

In fact, she and the other two people there were trying to calm him down and talk him into sleep for hours.

I have respected your advice to leave him alone. Completely. I haven't even texted him. And have trusted your care and direction, despite how confusing and scary it is at times.

Last night when we spoke I was upset primarily because I had expectations to get some clarity on what was going on - what the plan was (set boundaries...

abandon them?... etc) - what your perspective was (complete relapse, move on...?) but felt I was being shut down and out.
I continue to feel alienated and confused. On top of having the man I love fall into relapse.

So of course, i was upset but No excuse for allowing it to somehow upset you too.

I can't tell you how fucked and sad I felt when she flat out lied to me ... TO MY FUCKING FACE!!! And also, when I was not in Georgia...!!!

How many times did she, not just avoid the truth to protect me from unpleasanties that she would rather I had no knowledge of???
